

### Sanctions: Is it Really 'the West versus the Rest'?

Sanctions are an important tool for enforcing international standards. They are used frequently in a variety of fields: from traditional areas of inter-State relations to the world of sports and commerce. At the same time, sanctions have often been criticised as an instrument of the 'Global North' (or the 'West') to be used mainly against the 'Global South' (or 'the rest'): the UN Human Rights Council has recently highlighted "the negative impact of unilateral coercive measures on the enjoyment of human rights". This panel will explore the current sanctions practice of States and other international actors and test the popular (but perhaps simplistic) assumption that they are a tool of the Global North. To do so, the panel will include perspectives from different geographical regions and fields.

### **Current Issues in Law of the Sea**

For decades, deep seabed mining has been hailed as 'the next frontier' in resource exploitation — but also prompted major concerns. Work on the International Seabed Authority's 'mining code', intended to provide a comprehensive set of rules, regulations and procedures to regulate prospecting, exploration and exploitation of marine minerals, has heightened tension: well over 20 governments, as well as NGOs and scientists, have called for a moratorium or a precautionary pause on deep sea mining. At the same time, industry experts anticipate a 'commercial breakthrough' or even predict a 'new gold rush'.

Against this backdrop, the panel will bring together experts from practice and academia to take stock of developments and assess the role of international law and institutions in relation to deep seabed mining.



# International Settlement of Disputes

In a year where the cases before the ICJ are attracting more attention than ever before, the panel will examine the means by which disputes are being brought before international courts and tribunals and whether the criteria determining access to jurisdiction require revision. # IHL Database | Customary IHL To access the database, please go to: https://ihl-databases.icrc.org/customary-ihl

Mandated by the International Conference of the Red Cross and Red Crescent in 1995, the International Committee of the Red Cross (ICRC) conducted a study on customary international humanitarian law (IHL) which was published by Cambridge University Press in 2005. This study identified 161 rules of customary IHL and compiled relevant national and international practice. In 2007, the ICRC teamed up with the British Red Cross to update the practice section of the customary IHL study.

The aim of the Customary IHL Project is to provide a view into current national and international practice on matters of IHL. The original ICRC study on customary IHL is now available free of charge at the customary IHL database. This database provides rapid access to the rules identified by the ICRC as being part of customary IHL and enables users to examine practice from around the world. It is updated regularly with new national and international practice.

Since its inception in 2010, the number of users of the customary IHL database has grown markedly. The collection of practice on the database is an invaluable resource to government and military advisors, academics and other specialists involved in the practical application of IHL and for any further review of State practice to assess developments in customary IHL.

# 16 Space Law

Space is one of the most rapidly developing areas of technology and innovation. Nearly every aspect of our modern information-society relies on space-based technology: from communications and navigation to monitoring weather, natural resources and conflict. Looking ahead, space tourism and is rapidly becoming a reality while space mining is again being mooted as providing solutions to diminishing terrestrial resources.

It is also an area of great vulnerability. States are increasingly recognising the strategic importance of space in times of peace, competition and conflict. This year alone, cardinal prohibitions against placing nuclear weapons in space have been put to the test, the UN Security Council held its first-ever debate on space security and the role of space in modern warfare is being discussed on the morning news cycles.

The existing body of international space law, including the Outer Space Treaty, lays down the foundations for the use and exploration of space. However, the exponential growth in our use of and reliance on space requires further coordinated international action in developing norms to address new challenges. This Panel will discuss the ways in which the international community makes new rules against the backdrop of a challenging geopolitical climate and how it tackles the issues of governance, security and resources.
